Past Experience and Certifications:

Companies/Service Providers having at least last three (03) years relevant experience in dealing with similar nature of services and having valid Income Tax registration certificate, active tax payer (please attach company profile / certificate of reputation, copy of income tax registration certificate with tender form).

IMPORTANT:

- Companies/Service providers are required to quote all rates (for each item/job/work) without skipping any item in **Annex – A1/A2/A3**;
- Incomplete or partial bids will not be entertained and will be considered non-responsive and will be rejected;
- Escalation of rates under whatsoever circumstances is not allowed;

WORKING TIME: All the mentioned work/supply must be completed as per the specifications/ instructions on the specified locations within **15 days** after placement of the confirmed order.

- EARNEST MONEY:** Your offer must be accompanied by call deposit/pay order/demand draft amounting to PKR: 100,000/- made out in favor of Tameer-e-Khalaf Foundation (TKF) that will be returned after the finalization of the bidding process.

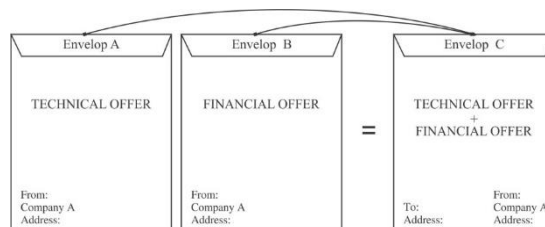

TKF may, at its discretion, extend the deadline for the submission of proposals, by notifying all prospective vendors in writing. The extension of the deadline may accompany a modification of the solicitation documents prepared by TKF at its own initiative or in response to a clarification requested by a prospective supplier.

7. CURRENCY AND PAYMENT TERMS FOR WORK ORDERS

Any Work Order (WO) issued as a result of this ITB will be made in Pakistani Rupees (PKR). Payment will be made within fifteen (15) working days after completion of work and submission of work completion report duly signed by TKF nominated person. Applicable Government taxes at admissible rate(s) shall be deducted at source from the payment made to the selected vendor(s). TKF at its own discretion can allow partial payments under this ITB but it will be decided at the time of contract awarding.

8. DISPUTE RESOLUTION

In case of any dispute or disagreement between TKF and the vendor, the dispute shall be referred to adjudication or arbitration in accordance with the laws of the Islamic Republic of Pakistan and the venue for arbitration will be Quetta.
